

## **Notice of Teams Sailing Trainings Event Lake Taupo Yacht Club supported by NZTSA**

15-17 December 2011

Lake Taupo Yacht Club is running a Teams Sailing Event in conjunction with the NZ Teams Sailing Association. There will be three days of training by experienced youth coaches. For the coaching the sailors should stay in the same boats for the two days. All teams should supply 420s for their own use.

Dates: 15-17 December. (Set up available evening 14 December).  
Venue: Lake Taupo Yacht Club, Landing Reserve, Taupo.

Format: Set up evening Wednesday 14<sup>th</sup> available.  
Thursday am welcome and briefing at 9am, coaching commences as soon as possible after.  
Friday/Saturday 9am ready to sail.

Training: This will be under the guidance of the NZTSA, with a selection of youth coaches. Ideally teams own coaches are also involved with this event.

Accommodation: Please advise ASAP if you need accommodation. Some billeting may be available locally.

Cost is provisionally \$710 per team, for 3 days (based on 6 teams). This includes lunches, and coaching, but not accommodation or boat hire if required. Costs may vary if number of teams varies.

Boats: International 420s, each team is requested to bring three 420 boats or organise a charter through NZTSA/ Ross Sutherland. Please ensure boat parts, spars foils, trolleys etc are in good condition, clearly labelled and also bring bailers and protest flags.

Extra inflatables may be needed for the team managers/coaches. Please advise if you intend to bring an inflatable, or would like to discuss this and your on water involvement.

Sailors: need to bring reasonable sailing gear and spare clothes.

Teams anticipated 6-8 per team.

If needed, the sailors from other teams may be able to makeup spots in teams,

Damage Bond: a refundable damage bond of \$500 shall be paid to NZTSA, if not already held.

In the event of a team causing major damage to a boat or boats, they may be required to pay an additional damage bond payment.
