**1 Rules**

- 1.1 The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing 2009-20012.
- 1.2 The YNZ Safety Regulations Part I shall apply.

**2 Eligibility and Entry**

- 2.1 The regatta is open to all 12ft Skiff Class boats that hold a current measurement certificate.
- 2.2 The skipper and crew and of each yacht shall be current members of a club affiliated to Yachting New Zealand and the NZ 12ft Skiff Owners Association.
- 2.3 Entries will be accepted until 01100 hrs on the 7<sup>th</sup> November 2009, by completing the attached entry form accompanied by a fee of \$65.00 plus any appropriate NZ 12ft Skiff Owners Association membership fees owing.
- 2.4 Late entries may be accepted at The Race Committee's discretion.
- 2.5 Measurement and safety checks may be required at any time during regatta .
- 2.6 A safety declaration form is to be completed at registration.
- 2.7 The race officer and / or committee has the right to refuse or accept any entry.
